

IMPORTANT - ALL PARTICIPANTS MUST READ THIS WAIVER, SIGN THIS FORM, AND RETURN PRIOR TO THE EVENT

**Release and Waiver of Liability and Indemnity Agreement to
Rod's Ride On Powersports and Thunder Ride for Juvenile Diabetes**

In consideration of being permitted to participate in any event sponsored, promoted, or directed by Rod's Ride On Powersports and Thunder Ride for Juvenile Diabetes, the undersigned (driver and passengers) for himself/herself, his/her personal representatives, heirs and next of kin HEREBY RELEASES Rod's Ride On Powersports and Thunder Ride for Juvenile Diabetes, and its and their respective parent corporations, subsidiaries, officers, directors, promoters, sponsors, employees, and agents ("releases") of all liability to the undersigned, whether caused by the negligent act or omission of releases or otherwise while the undersigned is for any purpose participating in such event. It is fully understood by each of the undersigned that there is some inherent risk associated with this event, including damage to vehicles.


IN ADDITION, the undersigned AGREES TO INDEMNIFY AND HOLD HARMLESS the releases from any loss, liability, damage, or cost they incur due to such participation by the undersigned, and any passengers (including minors) whether caused by releases' negligence or otherwise, and AGREES TO ASSUME FULL RESPONSIBILITY AND RISK for any bodily injury, death, or property damage from releases' negligence or otherwise while the undersigned is participating at this event.

IN SIGNING THIS RELEASE, EACH OF THE UNDERSIGNED HEREBY AGREES TO, ACKNOWLEDGES AND REPRESENTS THE FOLLOWING:

- That the owner/driver certifies that he/she has inspected this vehicle and same is in good mechanical condition and the vehicle has valid proof of insurance and current vehicle registration.
- That the owner/driver has informed himself/herself about the event and road conditions involved in the event, either by prior participation or by investigation into the event and roads.
- All occupants of vehicle will be registered. All drivers must have a valid driver's license.
- No occupants of vehicle shall will possess alcohol, non-prescription drugs, or be under the influence of any substance while on the road. Doing so means immediate expulsion.
- There will be at least one person 18 years or older who will be responsible for occupants of vehicle.
- That he or she has read the foregoing Release and Waiver of Liability and Indemnity Agreement; and understands that he/she is assuming liability and indemnifying releases for any damage or injuries.
- Rod's Ride On Powersports and Thunder Ride for Juvenile Diabetes and its subsidiaries and parent corporations cannot be held responsible for any damage that may occur to the vehicle while attending the event.
- Violation of these rules will result in the termination of all participants participation in the event and the forfeiture of all registration fees.
- I acknowledge the contagious nature of the Coronavirus/COVID-19 and that the CDC and many other public health authorities still recommend practicing social distancing. I further acknowledge that the Thunder Ride for Juvenile Diabetes (also referred to as "the Thunder Ride") has put in place preventative measures to reduce the spread of the Coronavirus/COVID-19.
- I further acknowledge that the Thunder Ride cannot guarantee that I will not become infected with the Coronavirus/Covid-19. I understand that the risk of becoming exposed to and/or infected by the Coronavirus/COVID-19 may result from the actions, omissions, or negligence of myself and others, including, but not limited to, the Thunder Ride staff, and other Thunder Ride participants and their families.
- I am voluntarily participating in the Thunder Ride for Juvenile Diabetes and acknowledge that I am increasing my risk to exposure to the Coronavirus/COVID-19. I acknowledge that I must comply with all set procedures to reduce the spread while attending the event.
- I attest that I am not experiencing any symptom of illness such as cough, shortness of breath or difficulty breathing, fever, chills, repeated shaking with chills, muscle pain, headache, sore throat, or new loss of taste or smell. I attest that I have not traveled internationally within the last 14 days. I attest that I have not traveled to a highly impacted area within the United States of America in the last 14 days. I do not believe I have been exposed to someone with a suspected and/or confirmed case of the Coronavirus/COVID-19. I have not been diagnosed with Coronavirus/ Covid-19 and not yet cleared as non-contagious by state or local public health authorities. I am following all CDC recommended guidelines as much as possible and limiting my exposure to the Coronavirus/COVID-19.

WAIVER MUST BE SIGNED & DATED BY ALL PARTICIPANTS:

For a participant under the age of 18 years, one parent, the parent with legal custody, or the minor's legal guardian must sign this release form and write the word "minor" and the age next to the minor's name. Drivers under the age of 18 years must be accompanied by a parent or legal guardian who is over 18 years of age. Any persons signing for a minor also indemnify Rod's Ride On Powersports and Thunder Ride for Juvenile Diabetes for any such minor's injuries.
